RELEASE, WAIVER AND ASSUMPTION OF RISK AGREEMENT

I, as a member or guest of the Eastern Ohio Conservation Club (EOCC), waive for myself and my executors, administrators, assignees or heirs, any and all rights and claims for damage, losses, demands and any other actions whatsoever I may have or which may arise against the EOCC and any and all staff, officers, trustees, members and volunteers of the EOCC, including but not limited to any and all injuries, damages, or illnesses suffered by myself, my guests and family, or related to or be connected with the EOCC. I, on behalf of myself and my executors, administrators, assigns or heirs, hereby expressly release and discharge the EOCC and any and all staff, officers, trustees, members and volunteers of the EOCC from any and all such claims.

I recognize that there is an element of risk in any adventure, sport, or activity associated with the outdoors. I am fully cognizant of the risks and dangers inherent in the use of firearms, archery equipment and hunting and have been informed of known special hazards in such activities. I certify that my family and I, including minor children, are fully capable of participating in the said activities.

Therefore, I assume full responsibility for personal injury to myself and/or to members of my family, or for loss or damage to my personal property and expenses thereof as a result of myself or of my family participating in said activities. I further understand that

EOCC reserves the right to refuse any person it judges to be incapable of meeting the rigors and requirements of participating in these I hereby expressly assume the risk of entering the Premises and of taking part in activities which include, but are not limited to, hunting, fishing, archery, and the discharge of firearms and firing of live ammunition.

I HAVE READ, UNDERSTAND AND ACCEPT THE TERMS AND CONDITIONS STATED HEREIN AND ACKNOWLEDGE THAT THIS RELEASE AND ACKNOWLEDGEMENT SHALL BE EFFECTIVE AND BINDING DURING THE ENTIRE PERIOD OF PARTICIPATION OF ANY ACTIVITY AT EOCC. I EXECUTE THIS RELEASE AND ACKNOWLEDGEMENT IN CONSIDERATION OF EOCC PERMITTING ME, MY GUESTS AND FAMILY TO USE ITS FACILITIES. I UNDERSTAND THAT THIS RELEASE AND ACKNOWLEDGEMENT IS NOT A PERMIT FOR THE GENERAL ACCESS OR USE OF EOCC GROUNDS OR EQUIPMENT AND DOES NOT GRANT MEMBERSHIP
